Both the parties after discussion and written communication with mutual consent can work together for any other specific case/ subject.

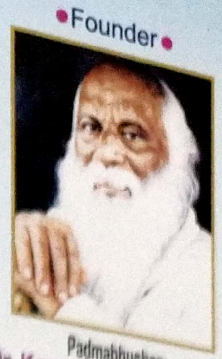
