

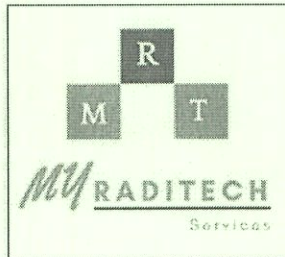

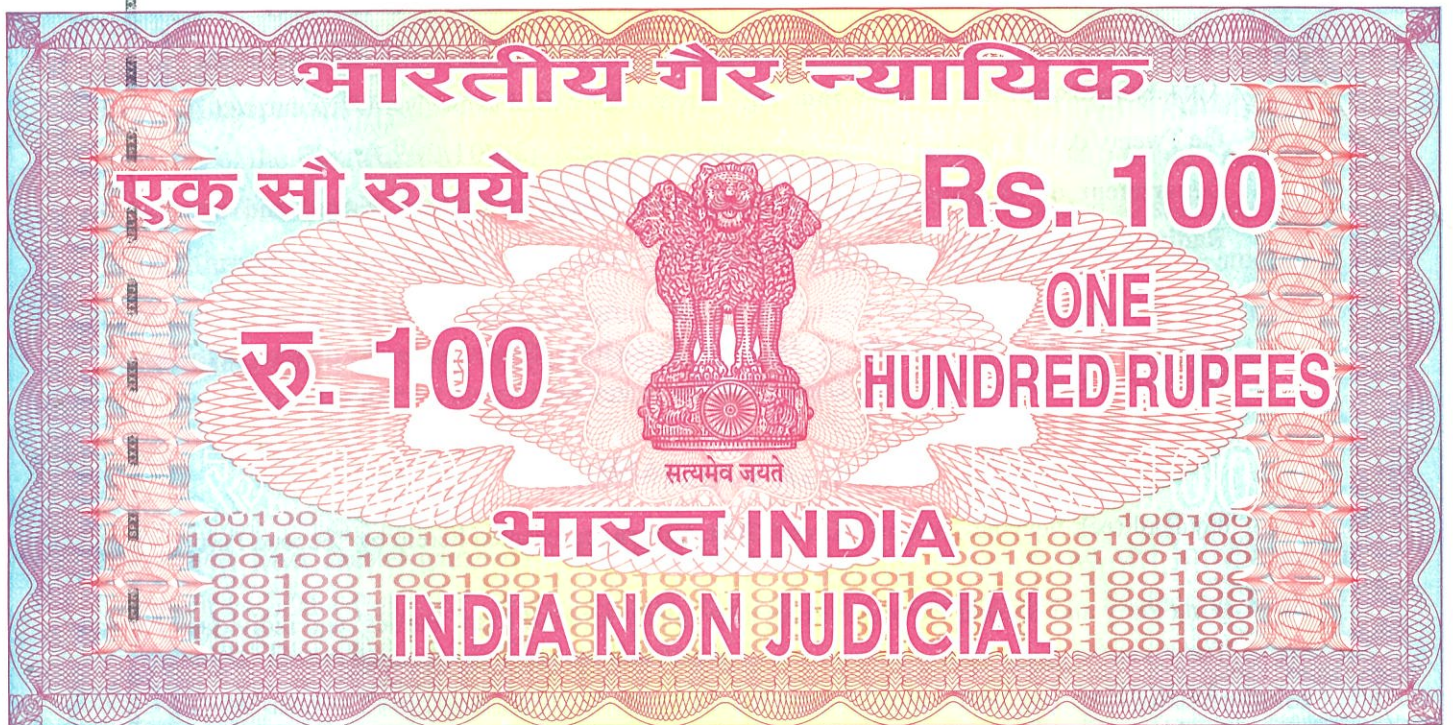

CLAUSE- 1 CO-OPERATION


